

Tuition & Fee Schedule

FOR THE 2010 – 2011 SCHOOL YEAR



Application Fee	\$75.00
K–5 Tuition	\$17,850/Yr.

Tuition payments are made twice a year and are due on June 1 and January 10, or paid monthly over 11 months.

Aurora School has a 30-hour volunteer commitment per family per year; 15-hours per single parent. Half of those hours are dedicated to fundraising hours. Families may opt to “buy out” time in cash @ \$25/hour.

EXTENDED CARE PROGRAM FOR THE 2010-2011 SCHOOL YEAR

The morning Extended Care program is available from 7:30 a.m. until class begins. The afternoon program is available until 6:00 p.m. every school day. On minimum days, the Extended Care program begins at 1:00 p.m. The Extended Care Coordinator and staff plan a variety of exciting, fun activities for children at different grade levels.

The “drop-in” rate for Extended Care is \$8.50 per hour. There are pre-paid rates offered at a discounted price. Costs for the pre-paid care are \$7.00 per hour (70–149 hours) and \$5.50 per hour (150+hours).

APPLYING FOR FINANCIAL AID

Aurora School seeks to provide educational opportunities for students who might require tuition assistance. Financial aid is awarded on the basis of need and availability for both continuing and new students. Our annual goal is to allocate an amount equal to 13% of the school's gross receipts for tuition assistance. The source of funding includes tuition revenue, fundraising, and foundation support. The Aurora Scholarship Endowment Fund was established in 1996 to develop a dependable source for financial aid in the future.

STEP 1	Complete and mail the School and Student Service (SSS) form	January 2011
STEP 2	Submit the Aurora Financial Aid Application, copies of your most recent W2 forms, copy of SSS application, and copies of federal tax returns from the last 3 years	January 28, 2011
STEP 3	The school will notify you of your tuition assistance award with your enrollment contract	March 11, 2011 or within one week of your child's assessment

All forms must be completely filled out, signed and turned in by the above-stated deadlines in order to be considered for financial assistance. If parents are separated, divorced or otherwise filing separate tax forms, copies of all the above must be submitted by both parties unless court orders granting sole custody to one parent are provided.

All information is confidential and is protected as such by the Aurora School Tuition Assistance Committee.

Fee waivers for the enrollment application fee and SSS processing fee will be considered in cases of financial hardship. The decision is made at the discretion of the Tuition Assistance Committee.
